## DETAILS OF STYLE FOR MANUSCRIPTS OF ARTICLES AND BOOK REVIEWS TO BE PUBLISHED IN "THE JOURNAL OF EUROPEAN ECONOMIC HISTORY"

1. *Footnotes, references, graphs, statistical tables etc.*: if tables or graphs are to appear in the text in the published version, the relevant indications should be made.
2. *Number and quantities*: in all figures and statistical tables, the English conventions for expressing decimals and thousands should be adopted (i.e. 0.5 = decimal point 5; 1,000 = one thousand). Terms for volumes and quantities not normally used in English or where the similar English term has a different value, should be written out in full or in a standard abbreviation indicated in the first reference.
3. *Presentation of titles of books and articles*:

4. *Abbreviations*: wherever possible, standard abbreviations for sources or publications with lengthy titles frequently referred to should be set out separately above the footnotes.
5. *Quotations and comments in footnotes*: as far as possible quotations and comments in footnotes should be avoided. Where they are considered as indispensable, they should be separated from bibliographical references so that they may be inserted without disturbing the ms: e.g.
